Election News

The Town of Cutler Bay Charter contains a provision that states that because of the vacancies that occurred in our town council during the November 2, 2010 election, our newly appointed Councilmembers would need to run for office and be on the next scheduled countywide ballot. On March 15, 2011, Miami-Dade County voters recalled Mayor Alvarez and Commissioner Seijas resulting in a special election being set for May 24, 2011.

At the end of the qualifying period on April 8, 2011, current Vice Mayor Sochin became unopposed, and Council District Seat 2 contained two candidates. A candidate for this seat withdrew candidacy. Due to this withdrawal, the Charter requires the reopening of the qualifying period and the scheduling of another election if fewer than two (2) candidates remain.

The Council met on April 14, 2011 to comply with the Charter provision and has scheduled the special election for Tuesday, June 28, 2011 with a run off if necessary on July 12, 2011.

Qualifying began on April 12, 2011 at noon and will end on April 25, 2011 at noon for the Council District Seat 2 position. Please contact the town clerk at 305-234-4262 or townclerk@cutlerbay-fl.gov for more information. Additionally you can stop in to Suite 101 to request qualifying papers.
