Recent Town Actions

Entered into an agreement with Tropic Landscaping and Lawn Maintenance Inc. for the purchase and installation of live oak trees within the town's designated right-of-ways; approved an agreement to provide improvements to the town center south parking lot; authorizing the issuance of a Invitation to Bid for the Southwest 97 Avenue roadway and drainage improvements relating to the provision of stormwater improvement project; recommended "project tasty," to be approved as a qualified Brownfield Business pursuant to Section 288.107, Florida Statutes; executed an agreement with Corzo, Castella, Carballo, Thompson, Salman, P.A. to provide design and engineering services for the Caribbean Boulevard roadway improvements project; approved the contract between the Children's Trust and the Town of Cutler Bay for the provision of an after-school program at Cutler Ridge Park; authorized the issuance of a Request For Proposal to effectuate the intent and purpose of the Florida Clean Energy Grant, and enacted an ordinance relating to the burglar alarm registration and provided a warning period.
