

RESOLUTION NO. 10-08

**A RESOLUTION OF THE MAYOR AND TOWN COUNCIL
OF THE TOWN OF CUTLER BAY, FLORIDA URGING
MIAMI-DADE COUNTY'S METROPOLITAN PLANNING
ORGANIZATION TO APPROVE THE TOWN'S
SUBMISSION FOR THE 2010 MUNICIPAL GRANT
PROGRAM FOR A BICYCLE AND PEDESTRIAN
MASTER PLAN; AND PROVIDING FOR AN EFFECTIVE
DATE.**

WHEREAS, the Town of Cutler Bay (the "Town") realizes that each year vehicle crashes involving bicyclists and pedestrians account for 40% of the traffic fatalities in Miami-Dade County; and

WHEREAS, the Town has submitted a proposal to the Miami-Dade County Metropolitan Planning Organization (the "MPO") for a Town-wide Bicycle and Pedestrian Master Plan (the "Master Plan") to encourage safe mobility options for residents and commuters alike; and

WHEREAS, the Town would like to encourage sharing the road and creating alternative transportation methods Town-wide; and

WHEREAS, the support of the MPO is critical to the creation of a strong, viable Master Plan to better accommodate today's residents of, and visitors to, the Town, as well as create a framework for future improvements; and

WHEREAS, the Town finds that this Resolution will promote the health, safety and welfare of the Town.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF CUTLER BAY, FLORIDA, AS FOLLOWS:

Section 1. Recitals. That the above stated recitals are true and correct and incorporated herein by this reference.


Section 2. Support. The Town Council hereby supports the creation of a Town-wide Bicycle and Pedestrian Master Plan (the "Master Plan") and urges the Miami-Dade County Metropolitan Planning Organization (the "MPO") to approve the Town's proposed use of the grant funds toward the creation of a strong, viable Master Plan.

Section 3. Transmittal. The Town Council hereby directs the Town Clerk to furnish a copy of the Resolution to members of the MPO Governing Board, the Director of MPO, the Financial/Grant Manager of MPO, the Mayor of Miami-Dade County, and the Board of Miami-

Dade County Commissioners immediately upon its adoption.

Section 4. Effective Date. That this Resolution shall become effective immediately upon adoption hereof.


