**SUBJECT:** Approved 2021 Transportation Alternatives (TA) Priorities

Dear Mayor Meerbott:

Pursuant to the Florida Department of Transportation (FDOT) correspondence dated May 18, 2021, FDOT, in collaboration with the TPO, has concluded the selection process for the FY 2021 Transportation Alternatives Application Cycle (see attached letter). On June 17, 2021, the Miami-Dade Transportation Planning Organization (TPO) Governing Board passed Resolution #28-2021 approving the attached 2021 TPO Program Priorities. The TPO's List of Program Priorities includes the **Cutler Bay SW 82 Avenue Roadway Improvements** in the amount of \$800,000 for Construction in FY 2023.

This project will be included in the Florida Department of Transportation (FDOT) District 6 Fiscal Years (FYs) 2023-2027 Tentative Work Program. After the approval of the Tentative Work Program by the Florida Legislature and Governor, the Miami-Dade TPO will incorporate the project in its FYs 2023-2027 Transportation Improvement Program (TIP) scheduled for adoption Spring 2022.

The funds for these projects will be administered by FDOT District Six through the Local Agency Program office.
