# 2019 DEPARTMENTAL HIGHLIGHTS

## **ADMINISTRATIVE SERVICES**

- Hosted and successfully documented a total of 14 employee trainings for Fiscal Year 2018-19
- Facilitated the 5th Annual iPrep Executive Internship Program for 24 Juniors from Cutler Bay Senior High School during 2018-19 school year
- Through an internship assignment, Executive Interns raised \$1,605 for the Relay for Life of South Dade, which benefits the American Cancer Society
- Executive interns completed a total of 100 community service hours in fiscal year 2018-19

- Installed new aluminum railings and decorative box planters along the front steps of the Town Center building entrance. While creating aesthetic improvements to the entranceway, these improvements allow residents and patrons an extra level of safety and accessibility to the Town Center
- Improved parking lot lighting by replacing lamps with new LED fixtures and brackets. In retrofitting the parking area, we increased visibility and reduced energy and maintenance costs
- The addition of two wall pack light fixtures on the north and west side entrance of the building increased brightness in the front courtyard
- The replacement of condensing coils in our hvac system helped boost the efficiency of power usage in the building
- Refreshed third and fourth floors by installing durable and water resistant new LVT flooring
- Upgraded drinking fountains with bottle fillers in the first and second floor encouraging the reduction of bottled water consumption in an effort to ensure less plastic waste and help to our environment
- Hosted "Careers in Stem Camp" in the Penthouse Suite during the summer 2019
- Coordinated and facilitated logistics for over 100 Community, Public Involvement events and Committee meetings hosted at the Town Center Building

# **NOTABLE TOWN TOPICS OF 2019**

RESIDENTIAL SHEDS	During the March 20 Town Council meeting, the Council voted to change the maximum number of sheds in a residential property from one to two.
PLASTIC STRAWS Banned	Keeping in line with the Town's long history of environmental social responsibility, the Town Council adopted an ordinance during the July 17 meeting that prohibits the use, sale, or distribution of single-use plastic straws in commercial establishments, by mobile vendors, and by special event permittees, as well as on Town facilities and property. Beginning January 1, 2020, the Code Compliance Department will begin issuing written warnings and on March 1, 2020 shall enforce civil penalties for violations.
TRANSIT: On Demand Services	As a result of a nearly \$600,000 Florida Department of Transportation grant the Town was awarded, an on-demand transportation service that will pick up and drop off riders right in front of their homes and transport them to and from the busway for free will soon be coming to Cutler Bay. Stay tuned to our e-notifications and social media pages to learn when this service will begin.
LINCOLN CITY Park Is Now A Natural Preserve	After receiving the results from a Natural Forest Community (NFC) Quantitative Evaluation that found Lincoln City Park qualifies as an environmentally endangered land, the Town Council adopted a resolution during the March 20 meeting designating the park as a natural preserve. The .6 acre passive park is located at SW 212 Street and 99 Avenue.
ENVIRONMENTAL STEWARDSHIP PROGRAM	During the May 15 Town Council Meeting, a resolution was adopted to establish the Environmental Stewardship Program. This program is designed to incentivize local businesses to rise to the challenge and voluntarily adopt green practices such as: conserve natural resources; reduce, reuse and recycle; and take affirmative steps to prevent pollution, among many other practices. Businesses that participate will also be rewarded with recognition and marketing efforts from the Town. This voluntary program is in the process of being completed and will be sent to businesses in Cutler Bay by early 2020.
NEW TOWN WEBSITE COMING SOON	The Town is getting a new website! The new website will provide residents with improved design and structure that will be easier to navigate through and find information. The new website will go live in early 2020.
AGE FRIENDLY ACTION PLAN ADOPTED	In January, the Town Council adopted and implemented the AARP Age Friendly Action Plan, becoming the 2nd municipality in Florida to do so. The plan serves as a guideline to be a more age-friendly community under the criteria established by the AARP and the World Health Organization. The plan is comprised of eight Domains of Livability: Outdoor Spaces and Buildings; Transportation; Housing; Social Participation; Respect and Social Inclusion; Civic Participation and Employment; Communication and Information; Community and Health Services. The Town's Action Plan has received recognition from the Miami-Dade Board of County Commissioners, Congresswoman Donna Shalala and the Florida Department of Elder Affairs.

MORATORIUM ON DEVELOPMENT	The purpose of the Moratorium on new building the Town Council adopted during the July 17 meeting is to enact additional regulations and/or requirements in order to preserve the Town vision and character. Applicants who submitted a completed development application to the Town's Community Development Department prior to the effective date of this Ordinance are exempt from the proposed moratorium Ordinance.
LAND SWAP	During the July 17 Town Council Meeting, the Town Council approved the purchase of approximately 16 acres located north of SW 212 Street and east of Old Cutler Road (a parcel of land better known as the "Potato Field") from GCF Investments Inc. while selling them the building and land where our current Town Hall sits (the Cutler Bay Town Center). Although the exchange has not been finalized, the immediate benefit would be a reduction in cost. The Cutler Bay Town Center building has been a drain on the Town's budget that results in losses of approximately \$744,000 per fiscal year. This land swap will remove that burden.
	The long-term benefits are much greater. The property that we are acquiring is currently zoned for mixed use commercial and residential development, with a residential component allowing a maximum of 30 units per acre (or approximately 480 units for all 16 acres). By transforming this property into a public space, not only will that prevent any development with multiple residential units from materializing on it, but it would also prevent the traffic that would come along with such a development.
	The vision for this piece of land is to transform it into an open community plaza and park complex that will house the future Town Hall and be a gathering place for the community. Once the transaction is finalized, the Town will hold several public visioning sessions to hear what residents envision for this space.
CRS CLASS 4	Effective October 1, 2019, the Town became the first municipality in Broward, Miami-Dade and Monroe Counties to reach a Community Rating System (CRS) Class 4 and only the third municipality in Florida to do so.
	The CRS is a voluntary program for communities participating in the National Flood Insurance Program (NFIP), with an objective to reduce flood damage to insurable property, strengthen and support the insurance aspects of the NFIP, and encourage a comprehensive approach to floodplain management.
	This achievement is the result of the efforts by the Town Council, the Flood Mitigation Advisory Committee, Town staff and the Town's professional consultants. One of the best benefits of reaching this CRS Class is that Residents and local businesses save 30% on their flood insurance premiums which equates to a total of \$1,823,789 savings for the Town!
VACATION RENTAL REGISTRATION	As the popularity of home vacation rentals continues to grow, so do the concerns of residents and neighbors regarding the excessive noise, excessive on-street parking, accumulation of trash, and diminished public safety that these rentals can sometimes bring. During the March 20 Town Council Meeting, an ordinance was adopted to include a section in the Land Development Regulations to regulate vacation rentals.

# **UPCOMING PROJECTS**

# FRANJO PARK RESTORATION AND IMPROVEMENT



After sustaining substantial damages in September 2017 by Hurricane Irma, the Town Council and staff have been working hard to not only restore, but improve Franjo Park. The Town Council has budgeted over \$1.4 million for this project, which will come from a combination of insurance proceeds (\$329,311), FEMA Grants (\$65,380) and Town funding.

The restoration of the park's baseball fields and three buildings will include: New LED Sports Lighting System; Shade Canopies; Dugouts, Backstops, & Foul Ball Fencing; Drainage System; Perimeter Fencing; Bermuda Sod in Athletic Field; Sidewalks Around Concession Area & Common Areas; and Laser Grading Clay Infields. The Community Room, Offices, Restrooms and Stand Facilities will all be upgraded.

The project has had several setbacks that extended the original timeline, however, we anticipate its reopening toward the end of 2020.

# **CANOE/KAYAK LAUNCH**



This \$597,000 project is made possible with the help of a \$200,000 grant Town staff obtained from the Florida DEP Land and Water. The project is currently under construction and will see the installation of a canoe/kayak launch, floating dock, pavilion and parking at the passive parcel of Lakes by the Bay Park.

We anticipate for this project to be completed in early 2020.

# **BIKE AND PEDESTRIAN IMPROVEMENTS**



Through the assistance of a \$360,000 Florida Department of Transportation Grant Town staff secured, bike and pedestrian improvements are coming to Cutler Bay in 2020! The project strives to improve public safety, enhance pedestrian mobility and provide a healthier community.

The project limits are in various locations in Town. Upgrading of pedestrian facilities (crosswalks, bus stops, sidewalks); Removing obstacles in the Right-of-Way; Ensuring Americans with Disabilities Act (ADA) compliance; Filling in sidewalk sections that are incomplete; Installing High Visibility Crosswalks.

The project has a tentative commencement of May 2020 and estimated time of completion as September 2020.

# FRANJO ROAD IMPROVEMENTS



Earlier this year, funding for the improvement of Franjo Road was approved by the Miami-Dade Transportation Planning Organization Governing Board.

The \$8,946,758 approved funding for this project will see the improving of Franjo Road from Old Cutler Road to SW 184 Street from two to three lanes that will include a center turn lane, curb and gutters, shared use path, storm drainage system, pavement markings and signage, signalization, and roadway lighting—much like the Caribbean Boulevard and Old Cutler Road improvements.

The Franjo Road improvement project was identified through the feedback we received at various public involvement meetings held when we were developing our Complete Streets Master Plan (funded by a TPO Grant). No estimated date of when this project will commence has been announced.





**FRANJO PARK | 20175 FRANJO RD.** This 5 acre park is currently under a restoration and improvement project, which should be completed toward the end of 2020.




