#### PLANNING AND ZONING DIVISION

- Reviewed 958 building permits for Zoning.
- Performed 727 Zoning inspections.
- Evaluated and processed 50 development zoning applications of which approximately 68% require Town Council review and approval.
- Approved the Site Plan administratively for Panera Bread.
- Approved the Site Plan administratively for the renovation of Point Royal Shopping Center, which included Burlington, interior build-outs for Tuesday Morning, Planet Fitness, parking, facade and landscaping improvements.

- Processed 21 Property Abatements.
- Held 12 Special Magistrate Hearings.
- Presented 196 cases in front of the Special Magistrate.

- The Town launched its first Citizen Transparency Portal in an effort to increase public trust by promoting an accountable government. The Transparency Portal allows the Town to provide the public with easy access to real-time government financial information for the current fiscal year, as well as a historical view of previous years.
- Guided the Town through its first 11 annual audits, the most recent of which was for the year ended September 30, 2017. In each of those years, the Town received an unqualified audit opinion from the auditors, which is the highest level of assurance an auditor provides. Further, the auditors had no adjustments to the Town's financial statements in

- any of the annual audits. Town Staff is currently preparing for the annual audit for the fiscal year ended September 30, 2017.
- Government Finance Officers Association (GFOA) Award for Excellence in Financial Reporting (11 consecutive years, starting with first submission for FY 2007).
- GFOA Distinguished Budget Presentation Award (four consecutive years, starting with first submission).
- The Finance Department continues to achieve increased efficiencies processing disbursementsand receipts in the accounting system as a result of implementing procedural changes in early 2015.

#### AFTER SCHOOL PROGRAM

- The After School Program received \$185,636 grant for the next five years from The Children's Trust. The program serves 72 children.
- The program received a \$61,500 grant from the Department of Juvenile Justice.
- Summer camp served, on average, 64 children per day for eight weeks.
- Over 100 attended the end of year program held at Cutler Ridge Elementary.



#### **AQUATICS PROGRAM**

- Listed as one of the Red Cross' top 50 aquatic facilities for the month of February.
- Provided swimming lessons and water safety classes to nearly 700 participants.
- Provided American Red Cross certification courses to 46 participants.
- Provided aquatic facilities to five Miami-Dade County public schools.
- Implemented a new lifeguarding certification program for the public.

#### **SPECIAL EVENTS**

- 10th Annual Cutler Bay Open Charity Golf Tournament raised \$7,115, benefiting the Cutler Bay Community Fund.
- 3rd Annual Wings over the Bay Event generated \$181.08 towards the Cutler Bay Community Fund.

#### **iPREP EXECUTIVE INTERNSHIP PROGRAM**

- Facilitated the 4th Annual iPrep Executive Internship Program wherein a total of 20 Juniors from Cutler Bay Senior High School participated in the 2017-18 internship program and successfully completed all program requirements prior to becoming high school Seniors.
- The interns Group Project/Relay for Life Team raised a total of \$1,200.00 to support the Relay for Life of South Dade.
- A total of 200 community service hours were completed amongst this group of student interns for this fiscal year.

#### **HUMAN RESOURCES/BENEFITS ADMINISTRATION**

- Finalization, release and implementation of the Town's 2018 Classification and Compensation Study and Analysis Update; consistently works with the Town Manager to ensure that all employees are accurately and adequately compensated and classified according to this pay plan.
- Continued the Employee Milestone Anniversary Recognition Program with a ceremony and celebration for employees completing milestone anniversaries with the Town.
- Facilitated the recruitment and onboarding of all summer seasonal/parttime staff utilizing the new NeoGov online employment application system.
- Further developed innovative programs to demonstrate employee appreciation in an effort to boost general morale (i.e., holiday goody bags, employee appreciation catered luncheons, improve on general communications of employee benefits and information, etc.)



- Continued the 2018-19 Open Enrollment process with the use of Colonial Life online enrollment services in order to continue the efficiency and affordability of employee benefits enrollment and administration.
- Continued to periodically distribute an Employee Satisfaction Survey, following major events like Open Enrollment, training sessions and workshops.
- Worked directly with Videographer and film crew to facilitate and assist in the direction and production of the Annual State of the Town Address video.
- Hired a new Public Information Officer (PIO), Executive Assistant to Town Manager and reclassified a part-time Events Specialist position to a full-time Events & Programs Specialist position following the resignation of former Programs Coordinator.
- Celebrated all 64 employee (combined full-time and part-time) birthdays on a quarterly basis.
- Continued to work with Town's legal counsel to update the Town's Employee Policies & Procedures; Official Manual release is expected for the Winter of 2018.
- Continued to work closely with the Town Manager to improve the overall structure

#### INFORMATION TECHNOLOGY SERVICES

- Renewed the Interlocal Agreement with Miami-Dade Information Technology Department (ITD) for basic IT support and maintenance services for an additional five years.
- Continued to work with Troy & Banks for utility invoice auditing services, generating a total of \$1,516.02 in credits issued since March of 2018.
- Modernized the Cutler Bay Town Center network: the new network design has improved management and security of the network switches, virtual environment and transitioned Wi-Fi service back to an in-house managed environment.



 Re-Designed Town internet connectivity at the Cutler Bay Town Center: this project established connectivity to the secure Miami-Dade County Data Center and provides internet service that leverages the secure Miami-Dade County Information Technology infrastructure. Miami-Dade County can upgrade and provide higher bandwidth to improve performance as Town of Cutler Bay

- business requirements grow to meet the needs of the community.
- Cybersecurity and Firewall Redesigned; Town Firewall was redesigned to provide a fully redundant and automatic failover solution.
- Re-Designed, installed and configured Town-hosted VMware: the Town's virtual server and data backup environment has been migrated to the Miami-Dade County Data Center. The new server virtualization services provide improve high availability, redundancy, eliminate the second floor data room cooling and power costs at Cutler Bay Town Center and provide a Continuity of Operations Plan (COOP) for the Town in the event Town Hall is affected by natural disaster or other emergency events. The Town's critical data and servers will be hosted by Miami-Dade County, in a facility categorized as a Main Data Cat5 Center.
- Procured and migrated to Microsoft Office 365 Subscription Services: this project allows for all 32 Town employees to work on the same platform and version for word processing, email, reports, etc. The implementation of this subscription service greatly reduces the annual cost of license renewals for IT software, support and maintenance, while ensuring that the Town follows industry best practices.
- Migrated onto Desktop Virtualization (VDI)
   Services: the migration of all 32 Town
   employees onto a virtual environment
   optimizes efficiencies by reconfiguring
   all workstations to thin-client solution,
   making it possible for users to connect
   to their desktops and applications from
   anywhere, anytime and from any internet
   capable device.

#### **PUBLIC WORKS DEPARTMENT**

- Completed the Manta Drive Roadway Improvement Project ahead of schedule and under budget. Project limits included Manta Drive between Old Cutler Road and Marlin Road. The project consisted of new sidewalks, Americans with Disabilities Act (ADA) crosswalks, driveway approaches, continuous valley gutter, improved drainage, asphalt milling and resurfacing, back of sidewalk harmonization, and street tree planting.
- Completed the Cutler Bay Middle School Sidewalk Connectivity Project, increasing pedestrian capacity and improving pedestrian safety around the perimeter of Cutler Bay Middle School (new sidewalks were installed along the following streets: SW 191 Street, SW 99 Avenue, SW 193 Street, SW 98 Avenue, and a portion of SW 194 Terrace). The project consisted of approximately half a mile of new sidewalks, tree relocations and new tree plantings, ADA ramps with truncated domes at all intersections along sidewalk paths, curb and gutters, minor drainage improvements, temporary signing and pavement markings, trash receptacles, and rest areas with benches.
- The Annual Earth and Arbor Day event held at Bel-Aire Elementary. was students were presented with The information on the effects of pollution and prevention. The Town donated 285 plants to enhance the schools existing Butterfly Garden. Before the students engaged in the activity, three stations were presented which included What is Stormwater? presentation, an EnviroScape stormwater management

- model and a video presentation, which provided a fun and learning experience.
- Participated in career/truck day events at two local elementary schools (Cutler Ridge Elementary and Whispering Pines Elementary).
- A total of 8.8 miles of the Town's roadways were milled and repaved.
- A total of 510 Bulky trash piles were reported to Miami-Dade County.
- Received and responded to 1,243 concerned resident calls within 24 hours.
- Erected 276 trees as a result of Hurricane
   Irma in Town right of ways.
- Removed 352 tree stumps as a result of Hurricane Irma in Town right of ways.
- Removed 49 dangerous trees as a result of Hurricane Irma in Town right of ways.
- Uplifted 545 trees and trimmed those requiring corrective pruning as a result of Hurricane Irma in Town right of ways.



#### **PUBLIC WORKS DEPARTMENT (CONTINUED)**

- Installed ten new bus shelters as a part of the Townwide Bus Shelters Phase I Project.
- Awarded the 2017 Tree City USA Award (for the 9th year in a row) and Tree City USA Growth Award (for the 6th year in a row) from the Arbor Day Foundation.
- Planted over 127 Florida native trees in Town's swale areas and right of ways.
- Continued removal of dead, damaged, and invasive tree species within the public right of way.
- Replaced damaged and potential trip hazard sidewalk flags: 4,983 Linear Feet (L.F.), which amounted to 997 Sidewalk Flags.



- Completed replacement of 36 damaged storm-drain aprons.
- Town's contractor "VisualScape" removed over 420 cubic yards of debris.
- Town's contractor SFM swept over 700 miles which removed approximately 80 tons of debris from roadways.
- Received results for Community Rating System (CRS) Cycle Verification. The

- Town received 3,054 credit points which is enough for a class 5 certification. The class improvement from 6 to 5 provides the Town's residents and additional \$179,224.00 in flood insurance savings annually.
- The Public Works Department worked closely with Town consultants at Wood Group formerly Amec Foster Wheeler to develop the Towns first Watershed Master Plan.
- Neighborhood Enhancement Action Team (N.E.A.T.) removed over 29 tons of debris from Town swales and roadways.
- Post Hurricane Irma all Town owned and maintained roads were cleared within the first two weeks and cleanup by Miami Dade Solid Waste had begun.
- Continued Townwide Storm-drain cleaning, including all of Bel-Aire Sec 11, Bel-Aire Sec 14, Bel-Aire Sec 15, Bel-Aire Sec 23, Cantamar, Old Cutler Common Unit One, residential neighborhoods. Total cleaned; 1,185 drainage structures, 77,006 LF of stormwater drainage pipe.
- The Public Works staff has continued their initial and refresher training by recertifying two staff members in Stormwater Level I & II, 2 staff members in Local Agency Program (LAP) Sub-Recipient Compliance Assessment Tool (SCAT) and 1 staff member in Public Records Management.
- Renegotiated the Towns open-ended vehicle equity lease with Enterprise Fleet Management and replaced the fleet with new vehicles (the old fleet generated a reimbursement of \$69,683.92).
